1. a) Non-compliance with accessibility provisions:

Sequence adjustments and clean hierarchical structuring of the displayed content to support keyboard navigation and the use of screen readers are missing (relates to WCAG 1.3.1 Information and Relationships and WCAG 1.3.2 Meaningful Sequence). The structuring and markup of headings (H1, H2, H3, etc.) are not correctly implemented (relates to WCAG 1.3.1 Information and Relationships and 2.4.6 Headings and Labels), which also limits the use of keyboard navigation and the use of screen readers. The main and secondary navigation, coherent and consistent focus indication, as well as the correct display order are not correctly implemented, which also restricts keyboard navigation and the use of screen readers (relates to WCAG 2.1.1 Keyboard, 2.1.3 Keyboard (No Exception), 2.4.3 Focus Order, 2.4.6 Headings and Labels, and 2.4.7 Visible Focus). These limitations also affect map display and map navigation. We plan to address these requirements in the next development cycles.
